### PAYMENT

1. After signing this application and payment of a \$100.00 deposit (which will be used to purchase club stock upon approval) your name will be submitted to the Board for approval (board meets second Tuesday of each month).
2. Family & single golf, family & single social, family and single associate golf, and family & single senior memberships are required to buy stock in addition to paying annual dues and any other fees that apply.
3. Junior memberships do not require stock purchase.
4. **Payment Options:**
  - a. **Full payment** – due effective the end of the month following board approval, then by March 31<sup>st</sup> of each annual renewal. Payments received after this date are subject to a \$50.00 delinquency penalty and all club privileges will be suspended on April 1<sup>st</sup> until payment is received.
  - b. **3 Month Pay** – due effective the end of the month following board approval if membership starts after March 31<sup>st</sup>, then in each new year payment will be due the last day of the month for January, February, March. Payments received after this date are subject to a \$50.00 delinquency penalty and all club privileges will be suspended on April 1<sup>st</sup> until payment is received.
  - c. **Monthly** – sign up for auto pay and your payment will automatically be withdrawn. Auto payment form required along with a voided check.
